- The bid will be opened in the presence of Bidders' representatives who choose to attend **14:00 Hrs on 2078-1-15 (April-21-2021)** at the **Office of Triveni Municipality, Toli, Bajura**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
