1. Triveni Municipality Office of Municipal Executive Toli Bajura towards the cost of Bedupani -Tapsikhola- Ratna -Paima Road Upgrading and intends to apply part of the funds to cover eligible payments under the Contract for TM/NCB/WORKS/1S2E/01/2079-80 Bidding is open to all eligible as per Section V of bidding document.
2. Triveni Municipality invites sealed bids or electronic bids from eligible bidders for the construction of Bedupani -Tapsikhola- Ratna -Paima Road Upgrading under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:
  - *Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 30380000/-*
  - *Minimum Work experience of similar size and nature: Two road Projects Of Similar Nature of cost 17100000/-*
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. 6. Pre-bid meeting shall be held at Triveni Municipality Toli Bajura at 2079/10/05
7. Sealed or electronic bids must be submitted to the office PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12 on 2079/10/09. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2079/10/09 at 14:00 at the office of Triveni Municipality Toli Bajura Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 562500/-], which shall be valid for 30 days beyond the validity period of the bid
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
